Re: Appointment of Brazilian Distributor

To Whom It May Concern:

Laser Ammo USA Inc, a USA corporation doing business as ("**Laser Ammo**") is the exclusive distributor in the Federal Republic of Brazil for all of the products provided by Laser Ammo LTD.

Laser Ammo hereby appoints CARAVAN EXPORTAÇÃO E IMPORTAÇÃO DO BRASIL LTDA ("Caravan"), as an exclusive reseller within the Federal Republic of Brazil, for the sale and distribution of the Laser Ammo products to government agencies for such specific orders that would be presented and agreed upon with Laser Ammo in advance.

Unless either party receives a five (5) day notice of termination from the terminating party, Brazil shall be and remain the territory of Caravan for a term of one (1) year from the date of execution of this appointment. The decision to terminate this dealership appointment remains at the discretion of either Laser Ammo or Caravan.

Laser Ammo agrees to sell, supply and deliver the Laser Ammo products to Caravan in such quantities and at times and delivery dates as are commercially reasonable. All orders placed by Caravan under this Agreement shall be subject to acceptance in writing by Laser Ammo. Upon Laser Ammo's acceptance thereof, such orders shall be binding contracts by Caravan to purchase and Laser Ammo to sell the Laser Ammo products.

After full payment of the purchase order, Laser Ammo shall supply and deliver the Laser Ammo products ordered by Caravan crated and ready for shipment F.O.B. Laser Ammo's distribution center in New York.

Caravan shall act at all times as an independent contractor hereunder, and nothing contained herein will create a relationship of principal and agent, employment, joint venture or partnership.

Caravan shall comply with all applicable laws, regulations, rulings and requirements of any governmental authorities now or hereafter having jurisdiction over the Laser Ammo products or the export, import, storage, sale, marketing, or promotion thereof, or the operation of Caravan's place of business.

The governing law for this agreement is New York Law.
