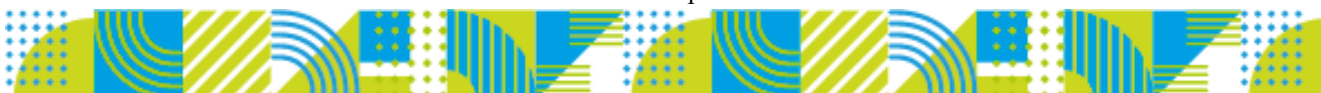

As a priority and especially important matter, due to the composition of our team, which includes members from abroad, in order to guarantee the alignment and efficiency of the project, we would appreciate it if you could prioritize the suggested dates, so that we can prepare our logistics.

Dates for visit between May 4th and 8th, 2026.

#### **RESPONSE 01**

We confirm the availability of the visit on the requested dates.



We recommend a team composition of a maximum of 3 participants per visit.

We request, as per item 16.3 of the tender, the submission of the proposed itinerary indicating which areas of the BLOCKS and facilities you are interested in visiting by date.

In compliance with item 16.3.1, we request that, along with the itinerary, you submit the Confidentiality Agreement, duly signed by your legal representative, according to the model in ANNEX B – MODEL OF LETTERS AND DECLARATIONS.

We inform you that visits must take place during Cagece's business hours, from Monday to Friday, from 8:00 am to 12:00 pm and from 1:00 pm to 5:00 pm.

As per item 16.3.4 of the Tender, under no circumstances will it be permitted to schedule visits with different BIDDERS on the same day and time; therefore, the proposed itinerary for the technical visits must be submitted at least 3 (three) days before the start date of the visits.

Finally, we inform you that the technical visits must be carried out by representative(s) of the BIDDER, duly identified by means of document(s) proving their status, and at least one of the representatives must present a valid professional registration with the Regional Council of Engineering and Agronomy (CREA), with proof of compliance with item 16.4.1 to be sent in advance, along with the itinerary.

To comply with item 16.4.1, the BIDDER representative professionally qualified with CREA must, on the day of the visit, present documentation proving their affiliation with the BIDDER, which does not need to be permanent.
