ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, POMERWASSER AMBIENTAL S.P.E. S.A. (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

Withdrawing your consent
