ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, AAHBRANT ENGENHARIA E CONSTRUÇÕES LTDA (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
